

Terms and Conditions Cultural Dress/outfit Competition 2024

Date: 28th of March

Location: Bendigo Kangan Institute's Broadmeadows Library

Time: 11.30 am – 1 pm

Event concept: Student event to celebrate Cultural Diversity Week, showcase diverse cultures, promote inclusion, and embrace diversity.

Student Competition: Cultural dresses and outfits competition amongst current students at Bendigo Kangan Institute.

Target Group: All Kangan Institute's current students.

Terms and Conditions:

1. Promoter:

The Promoter is Bendigo Kangan Institute (ABN 74 802 942 886) trading as Kangan Institute, a TAFE institute established under the Education and Training Reform Act 2006 (Vic) of Private Bag 299, Somerton, Victoria 3062 (RTO 3077 & CRICOS 01218G).

2. Conditions of Entry:

The entrant accepts these Terms and Conditions of entry to the Promotion by completing the registration process through the QR code located on the event's promotional poster. The Terms and Conditions of entry can be found on the QR registration page.

3. Eligibility:

The competition is open to all current students at Bendigo Kangan Institute.

Entrants under 18 years of age must obtain permission from their parent or legal guardian to enter. The Promoter may require any such entrant's parent or legal guardian to sign a release at the Promoter's discretion in which the parent or legal guardian accepts responsibility for the acts and forbearances of the entrant. The release will include the parent or legal guardian's full name, address and telephone number. If the entrant is a winner, a failure to agree to the release and provision of these details to the Promoter will invalidate the winner's entitlement to the prize, subject to State legislation.

4. How to enter the competition:

To enter the competition, participants must complete the registration form via the QR code on the event promotional poster by Monday 25 March 2024.

5. Traditional Costume Guideline:

- a. A traditional costume refers to clothing that represents the cultural heritage, history, and customs of a specific culture or region.
- b. Participants should ensure that their costumes accurately reflect the traditional attire of the chosen culture.

6. Entry Requirements:

Each participant must submit a registration entry through the QR code provided on the poster invite by these guidelines.

Entries must be original and solely created by the participant.

Multiple entries are not permitted.

Late entries will not be accepted.

7. Registration closing date:

Each participant must submit a registration entry through the QR code provided on the poster invite by these guidelines by Monday 25 March 2024.

8. Judging:

Entries and traditional outfits will be judged by a panel of judges selected by the Bendigo Kangan Institute – Student Experience Team.

Judging criteria will be based on creativity, cultural representation, and overall quality.

- a) **Cultural representation:** a costume that represents a cultural heritage.
- b) **Creativity:** Uniqueness of the costume and concept.
- c) **Overall quality:** Judges' opinion and overall impression of the costume.

Judges' decisions are final and binding in all matters related to the competition.

9. Prizes:

Prizes will be awarded to winners as specified for each competition category: first prize, second and third prize.

There will be three prizes given to students entering the best cultural dress competition. The judging criteria for the competition will be based on cultural representation, creativity and overall quality.

9.1 First prize category: Best cultural outfit, will receive a \$100 gift card.

9.2 Second prize category: Second best cultural outfit, will receive a \$70 gift card.

9.3 Third prize category: Third best cultural outfit, will receive a \$50 gift card.

Prize details are non-transferable and may not be substituted for cash or other prizes.

Prizes are rewarded as gift cards.

9.4 The total prize pool is \$220.

10. Notification of Winners:

Winners will be notified by email or phone using the contact information provided at the time of entry. Or in person, at the conclusion of the competition.

If a winner cannot be contacted or does not respond within 8 days of notification, the prize may be forfeited, and an alternate winner may be selected.

11. Intellectual Property:

Participants retain ownership of the intellectual property rights to their entries.

However, by submitting an entry, participants grant Bendigo Kangan Institute a non-exclusive, royalty-free, worldwide license to use, reproduce, modify, adapt, publish, and display the entry in connection with the competition and for promotional purposes.

12. Personal information

If an entrant does not provide their personal information, the Promoter will not be able to enter the entrant in the competition.

13. Disqualification:

Bendigo Kangan Institute reserves the right to disqualify any entry or participant that violates these terms and conditions or engages in any fraudulent or inappropriate conduct.

14. Acknowledging and promoting success

Each prize winner acknowledges and agrees that the Promoter may publish the details of the prize winner including photographs taken by the Promoter in the Promoter's marketing material or reports, including on social media, the Promoter's website and in brochures or newspapers.

15. Limitation of Liability:

Bendigo Kangan Institute, its affiliates, officers, directors, employees, and agents shall not be responsible for any lost, late, misdirected, illegible, or incomplete entries, or for any computer-related, online, or technical malfunctions that may occur.

By participating in the competition, participants agree to release and hold harmless Bendigo Kangan Institute and its affiliates from any and all liability, claims, or actions of any kind whatsoever for injuries, damages, or losses to persons and property that may be sustained in connection with the receipt, ownership, or use of any prize or while preparing for, participating in, and/or traveling to or from any competition-related activity.

16. Modification or Termination:

Bendigo Kangan Institute reserves the right to modify, suspend, or terminate the competition at any time for any reason without prior notice.

17. Governing Law:

The competition and these terms and conditions will be governed by and construed by the laws of privacy and confidentiality as well as Bendigo Kangan Institute internal policies and procedures.

By participating in the competition, participants agree to abide by these terms and conditions. Any violation of these terms and conditions may result in disqualification from the competition.

18. Drug and Alcohol:

By participating in the competition, all participants agree to abide by Bendigo Kangan Institute's (BKI) policy on alcohol and drugs, aimed at promoting a healthy and safe environment. This includes refraining from attending BKI premises or events under the influence of alcohol or
